President's Report – Len Hardy

- Len discussed the BHS Booster Club scholarship. Applications were available, on 3/1, in the guidance office. This is the same application that is used by other scholarships. These are due on 04/13/2006 and presented on 05/19/2006, at Senior Recognition night. The teach committee is being put together. - Varsity awards night will be held on May 24, 2006, at Villa Olivia. All sports & activities will be honored. The booster club will pay the cost of each varsity student that plans on attending the dinner.
- The dance team will compete at the IDTA performing in both Hip-Hop & lyrical.
