PRESIDENT'S REPORT – Brian Sanders:

Fireworks at Hawkfest were canceled due to weather. They have been rescheduled for senior sundown on May 24th.

Concession fees taken by main Boosters from individual clubs who are selling concessions has been 20% of earnings. Main Boosters collects about \$4,000 a year. Main Boosters then spends about \$2,000 a year for permitting and other costs related to running concessions. A decrease to collecting 15% would still give main Boosters about \$1000 as a buffer for any unexpected costs (such as broken equipment) for each year.

If the 15% collection fee is discouraging any clubs from selling concessions, please contact the Executive Board and flexibility on the fee can be waived.

<u> ATHLETIC DIRECTOR'S REPORT – Jeff Bral</u>

The role of the Athletic Director is to serve as a liaison between Boosters and Bartlett High School. The Athletic Director is not part of the Booster board and does not make decisions regarding Booster procedures.

Indoor Hawkfest this year generated more income than past years.

Rain caused some changes to sports this past week in an effort to preserve fields.

Girls volleyball will host a super sectional at BHS on November 3. Girls tennis was just short of qualifying for state.

Next year our conference will be Upstate 14 with 4 new schools added. The conference will now include West Aurora, Riverside Brookdale, Elmwood Park and Ridgewood. There will be a West division which includes all five U-46 high schools as well as Aurora East and Aurora West. All other schools will be in the East division. Not all schools will play each other, but schools will play all teams in their division in addition to a few from the other division.

Winter sport registration is open.

District U-46 is looking at new models for financing clubs and sports. Currently, the Athletic Director receives \$70,000 a year to finance all clubs and athletics at Bartlett High School. This money needs to be spent by April, which leaves a gap through the end of the year if financial needs arise. Participation numbers could potentially be factored into the financing.

Uniforms need to be purchased from an approved U-46 vendor.
